## **Treasurer's Report**

K Cullen provided balances in bank accounts. Financial reports were provided as of June 30<sup>th</sup>. Not including current taxes due, there are 6 properties with arrears including the 2 that have significant amounts. 10 additional are missing marina fees, interest, or FOI charges. Outstanding marina bills include 2 for docks and 3 small vessel fees. E Sears was notified of outstanding dock fees.

P Naryniecki contacted K Cullen to request that \$4,000 be transferred from Knollcrest Tax District to Knollcrest Realty Corp to cover all of FY15-16 property and water system taxes. Taxes have progressively escalated from \$3,000 to \$4,000. E DeLeo questioned if assessment would be disputed. This would need to be taken up with KREC.
